# 15/116 BJA RE-STRUCTURE

The President confirmed that Council was content with the Chief Executive's presentation regarding the new structure which covered the need for redundancies and programme cuts and prepared the way forward in terms of working closely with Areas.

## 16/117 BJA REPORT AND ACCOUNTS

Queries that had been raised on the Annual Report and Accounts were clarified by the Chief Executive. The Report and Accounts was ratified by Council.

### 16/118 KATA

The President outlined Council's concern regarding the lack of Kata knowledge within the grading structure. It was felt that Kata was currently being ignored and it was suggested that Kata should be taught either from Green belt or from Brown belt. The President confirmed that the IJF requests a working knowledge or some experience in the Kata and there is currently a push from EJU and IJF for greater interest in the Kata.

Eddie Awford, as Chair of the Kata Commission, had met with Mick Leigh after the Council meeting to discuss and clarify current issues.

## 16/119 COUNCIL COMPOSITION
