The next stage is to work through the appeals process and variables on whether that main principle can be changed.

RS wished his praise to Jessica Hastings (JH), Events Manager be noted. AS added that the IBSA President, Janos Tardos, has requested that we host the event again;</li> <li>European Championships in Montpellier will be RS's last event as BJA Chair, which has 17 fighters competing;</li> <li>RS has been given responsibility for Veterans (Masters) Judo by the IJF with the key task to develop the European Open Veterans Tour in 2024 and it is hoped that one of the first events will be hosted in the UK;</li> <li>Shohei Ono is currently in Edinburgh but is very keen to visit the NTC and travel with the GB team;</li> <li>In line with the IJF and IOC to allow Russian and Belarussian athletes to compete under a neutral flat, the EJU are allowing this at senior competitions. However the IJF and EJU have employed resources to look into the backgrounds of any athlete wishing to compete.</li> </ul>

#### **International Relations:**

- AS and JH had attended the EJU Administration Conference where the contract for JudoManager (events management system) had been finalised. This can also be utilised by the Home Nations:
- Finalising dates for the practical week of the 2024 IJF Academy but highly likely we will be hosting this at the NTC again.

#### **Domestic Activity:**

- Initial indications are that our award from UKS will be the same as the last cycle, at £7.2m, although in reality this is a 20% decrease due to increased costs;
- UKS have requested that we look at working more collaboratively with British Wrestling and they are joining us for our UKS Engagement Panel Meeting on Thursday 16 November:
- Good meeting with Birmingham City University in regard to areas of growth across the West Midlands;
- Dr George Kerr CBE is now President Emeritus of JudoScotland and Colin McIver now President;
- Quarterly Home Nations CEO Meetings taking place as well as specific department meetings, ie: safeguarding and marketing. Further specific discussion is required around Home Nations club membership in early 2024;
- A -57kg fighter has requested to change to compete for another country, which will be confirmed by Friday 27 October.
   This point triggered discussion around the need to discuss athletes changing country with UKS, IJF and EJU as there is a lot of investment both financially and person resource made into fighters on the programme and changing does not disadvantage them in any way, ie in regard to losing qualification points.

#### 67.10 FINANCE & OPERATIONS UPDATE

SH's report was taken as read with a few additional points raised by SH below:

- SE Together Fund/Tackling Inequalities Fund finalised at the end of September with £350k being distributed directly to clubs.
   Now just working on case studies which will be shared on social media:
- Membership income on target and no requirement to reforecast for remainder of 2023/24;
- Accruals high as accrued for University rent which has not been invoiced as yet;
- Potential opportunity to purchase assets from Birmingham Council who have been declared bankrupt, eg: accommodation;
